- Patent means a unique innovation. Innovation means a new way of doing something, offering a new technical solution to a problem. IPR grant of exclusive rights of an invention – PRODUCT / PROCESS to the owner.
- Who can File the Patent? Eligibility:
 - Business Owner – with and idea or product to patent
 - Research Scientist – with a new concept or formula
 - Professional (Employee) – with a new idea for software
 - ME or PHD holder – with research project

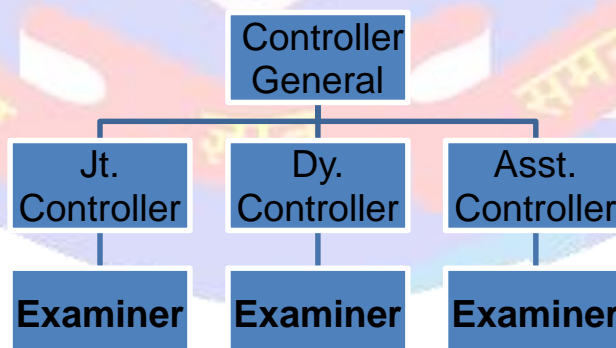
- If we registered our patent then it stops others from making, using, offering for sale, selling or importing patented invention without Permission of owner.



- **Jurisdiction:**

- **Address for service-**

- Place of residence, domicile or business of the applicant (first mentioned applicant in the case of joint applicants)
 - Place from where the invention actually originated.
 - Address for service in India given by the applicant when he has no place of business or domicile in India. Like Delhi, Kolkata, Chennai, Mumbai.
